




#### NYMEX Natural Gas Futures in 2020 and 2021

- April-October 2020 Henry Hub spot prices averaged \$1.89/MMBtu
  - 550-600 Bcf of LNG exports shut-in amid weak global prices exacerbated downturn
  - Producers curtailed 200-300 Bcf of production in response to low prices
- 2021 injection season likely to start 500-800 Bcf lower storage vs. 1,986 Bcf in March 2019
- Core supply/demand fundamentals will be 5.3 Bcf/d tighter



#### A. General Information

The City of Rio Hondo (the "City") is accepting Request for Qualifications (RFQ) for the position of Rio Hondo Municipal Court Judge. All Municipal Court Judges duly qualified are invited to submit proposals with their qualifications for the provision of these services.

There is no expressed or implied obligation for the City to reimburse responding individuals/firms for any expenses incurred in preparing a proposal in response to this request.

#### II. NATURE OF SERVICES REQUIRED

#### A. General

The Judge will preside over Municipal Court for all class C Misdemeanors, violations of City ordinances, pre-trial conferences, jury trials and other cases appropriately tried in a **Municipal Court of non- record.** 

The City's Municipal Court Judge is appointed by the City Commission for a term of two (3) years, (follows Mayoral Election) and works as an independent contractor. Currently, the Municipal Court holds one court day a month (4<sup>th</sup> Friday) or when necessary to dispose of a case or to issue court subpoenas, arraignments and magistrations. The judge's office hours will be Friday from 2:00 pm to 5:00 pm., of every week.

The Judge is compensated \$400.00 per week with the understanding that the Judge must also be willing to be contacted nights, weekends, and holidays for approval of Criminal Arrest Warrants, Search Warrants and to magistrate capias pro fine warrants.

#### Qualifications:

- 1. A municipal judge or associate/alternate municipal judge in the State of Texas for court of non-record or record.
- 2. Juris Doctorate degree and have graduated from a law school accredited by the American State Bar of Texas.
- 3. Must Reside in Cameron County or reside near Rio Hondo.

The City of Rio Hondo is a Type A General Law form of government since of 1927. The City Commission consists of five members and a Mayor, each elected at large for a term of three years. The City Manager is hired by and reports to the City Commission and directs all City operations.


