The Government Body of the City of Rio Hondo, Texas met in a Regular Meeting on August 23, 2022 at 6:30 pm in the Commission Chambers at City Hall, with Mayor- Gustavo Olivares Presiding- Present, Mayor Pro-Tem- Margaret Perez and Commissioners, Juan Garza- Present, Esteban Bocanegra- Present, Olga Gallegos-Present, and Jose Cavazos- Present.

PLEDGE OF ALLEGIANCE -Led by Mayor Olivares at 6:30 p.m.

INVOCATION: By Commissioner Perez

Regular Agenda:

- 1. Mayor's and Commissioner's Report No Reports
- 2. Reports: Administrator, Bridge-Fest 2022 Public Safety A report was given by the City Administrator and the Police Chief.
- 3. Public Comment Period: Please Note- The Public Comment Period is designated for hearing concerns regarding City of Rio Hondo Public Policy or City of Rio Hondo business that is or is not on the agenda or items listed on the agenda.
- 4. Consideration and Action on the City Commission Minutes of July 26, 2022, and August 9, 2022 City Commission Meeting. After reviewing the minutes Commissioner Perez made the motion to approve the minutes and seconded by Commissioner Cavazos and the motion passed unanimously.
- 5. First Public Hearing and Action condemning and ordering the demolition of a structure located on Lot 18, Block 28 Rio Hondo Original Townsite (214 Ebony Street). Mr. Medina told the City Commission that this house was an dilapidated and a fire hazard. The owners were deceased and notices have been returned. The city has weedy lot fines issued on this lot and the neighbor complain the tall grass and rats. Commissioner Bocanegra made a motion to condemn the unit and seconded by Commissioner Cavazos. The motion was passed unanimously.
- 6. Consideration and Action authorizing the City Administrator and the City Attorney to develop or reauthorize the Industrial Development Corporation for the participation in Industrial Revenue Bonds Program. Mr. Medina explained that a developer wanted to build a steel plant and need the taxexempt bonds. The Rio Hondo Industrial Development Corporation is the organization can be the conduit to do so. The IDC has been dormant since 2009 and will need to be authorized. Mr. explained that he need permission to reauthorize the IDC and work with Tom Spugeon and the City Attorney to reactivate the IDC. A motion was made by Commissioner Perez seconded by Commissioner Bocanegra and the motion was passed unanimously.
- 7. Public Hearing on the City of Rio Hondo Budget for Fiscal Year October 1, 2022, and ending on September 30 2023. Mr. Medina discussed the budget the City Commission. No Action was taken.

ORDINANCE NO 2022--05

AN ORDINANCE LEVYING AD VALOREM TAXES FOR THE MAINTENANCE AND OPERATION OF THE MUNICIPAL GOVERNMENT OF THE CITY OF RIO HONDO, TEXAS, BEGINNING OCTOBER 1, 2022, AND ENDING SEPTEMBER 30, 2023 DISTRIBUTING THE TAX LEVY AMONG THE VARIOUS FUNDS, AND PROVIDING FOR A LIEN ON REAL AND PERSONAL PROPERTY TO SECURE THE PAYMENT OF TAXES ASSESSED

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS.

Section 1. That there is hereby levied and there shall be collected for the maintenance and operation of the municipal government of the City of Rio Hondo, Texas for the 2022-2023 Fiscal Year upon all property, real, personal, and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.812207 cents on each One Hundred Dollars (\$ 100) valuation on property.

THIS TAX RATE WILL NOT RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

Section 2. That there is hereby levied and there shall be collected for the City of Rio Hondo, Texas to provide for Interest and Sinking Funds for the 2022-23 Fiscal Year upon all property, real, personal property, within the corporate limits of said City subject to taxation, a tax of \$0.181522 cents on each One Hundred Dollars (\$100) valuation on property.

All receipts for the City not specifically apportioned are hereby made payable to the General fund.

Taxes levied under this Ordinance shall be due October 1, 2022, and if not paid on or before January 31, 2023 shall immediately become delinquent.

Section 4. All taxes shall become a lien upon the properly against which assessed, and the tax assessor and collector for the City of Rio Hondo is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and Ordinances of the City of Rio Hondo shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the interest and penalty collected from such delinquent taxes shall be appropriated to the General Fund of the City of Rio Hondo. All delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law.

Section 5. That this ordinance shall take effect and be in force on October 1, 2022.

All taxes shall become a lien upon the properly against which assessed, and the tax assessor and collector for the City of Rio Hondo is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and Ordinances of the City of Rio Hondo shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the interest and penalty collected from such delinquent taxes shall be appropriated to the General Fund of the City of Rio Hondo. All delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law.

Section 5. That this ordinance shall take effect and be in force on October 1, 2022.
