2. Consideration and action on the May 30, 2025, July 11, 2025, July 15, 2025 and July 22, 2025 City Commission Minutes.

Commissioner Bustamente made a motion to approve the Minutes from May 30, 2025, July 11, 2025, July 15, 2025 and July 22, 2025 with corrections on July 22, 2025 Item #6. Commissioner Gallegos seconded the motion, all voted "aye" to approve; motion carried.

3. Presentation on the status of the Bridge Fest Festivities,

Mr. Betancourt from Wrecking Crew Jams reported to the commission that Bridgefest will be held on November 28, 2025 (Black Friday). Bridgefest will be held on both sides of the river which will include the Spotted Sea Trout Park. Tractors & trailers will be used as a shuttle service. Festivities will begin at 11 am on both sides of the river. They will end at 7 pm on City Side and on Park side they will end at midnight. Event will be live streamed by Midnight via RGV Photo & Drones. The

Commissioner Cavazos asked if this was on a temporary trial basis because to his understanding we do not have a Public Works Director position; what we have is Water Operator and Wastewater Operator.

Mr. Medina stated that was correct but under TCEQ's recommendation we need to separate the duties from Public Works and Water & Wastewater Operations. So that is why we are doing this on a trial basis to separate the duties. Mr. Medina added also that Mr. Garcia does not hold a license for Water Operator and per TCEQ he cannot be at the Water Plant without it. This interim position will be for 90 days.

Commissioner Cavazos made a motion to appoint Osvaldo Garcia as interim Public Works Director. Commissioner Bocanegra seconded the motion, all voted "aye" to approve; motion carried.

6. Consideration and Action on a Proclamation celebrating the 10th Anniversary of the University of Texas Rio Grande Valley.

Mr. Medina stated that UTRGV reached out to City of Rio Hondo to pass this Proclamation in support of their 10th year Anniversary.

Commissioner Bocanegra made a motion to approve the Proclamation for the Celebration of UTRGV's 10th year anniversary. Commissioner Bustamante seconded the motion, all voted "aye" to approve; motion carried.

7. Status Report on the Public Safety Department regarding staff and equipment needs.

Chief Longoria reported that we currently have 3 full time officers plus 2 more will be coming on board for a total of 5 which will leave 1 more position to fill. Mr. Longoria is running background check on the 6th candidate. Per Chief Longoria will should be fully staffed in one week. We have 2 reserves and 2 more will be coming soon. As far as the Fire Department goes we have 18 volunteers and half of those we have acquired in the past 2 weeks. Mr. Longoria introduced Officer Perez, Jared – top responding volunteer, and Assistant Chief Arnold.

Chief Longoria has been updating policies and obtaining some equipment that is needed. Chief Longoria has been working closely with Mr. Medina. Chief Longoria stated that he is working on getting a vehicle donated.

10. Consideration and Action to redesign the Heywood Street stormwater project to the secondary outfall.

Per Mr. Medina City was going to use the outfall from Mr. Serna's property. The City had an agreement with him but Mr. Serna wants more money which the City does not have plus he wants to change the location of the pipe, therefore this outfall is no longer feasable. City will need to use alternate route which is going North on N. Arroyo to the secondary outfall where Bates and Arroyo meet or the ditch that is East of Town through Robert Garza.

Commissioner Bocanegra made a motion to redesign the Heywood Street stormwater project to the secondary outfall. Commissioner Cavazos seconded the motion, all voted "aye" to approve; motion carried.

11. Consideration and Action accepting the letter of voluntary annexation of Rio Hondo Park Block 35, 1 acre, and Rio Hondo Park Block 35, 4 acres, from Miguel N. Alaniz.

Mr. Medina stated that before finalizing annexation Mr. Alaniz needs to write a letter stating he is voluntarily annexing.

Per Mr. Drinkard the letter is not acceptable. The letter is not sufficient. The letter has to be in a petition format, it also needs to state if the property will be used for agricultural purpose. This is all part of a subdivision plat which is outside city limits within the ETJ. City will provide sewer service and East Rio Hondo will service the water. Per Mr. Drinkard there needs to be a Public Hearing.

Commissioner Bocanegra made a motion to table this item. Commissioner Cavazos seconded the motion, all voted "aye" to approve; motion carried.

A) <u>SERVICE TO BE PROVIDED WITHIN SIXTY (60) DAYS OF ANNEXATION</u>, UNLESS OTHERWISE PROVIDED.

- 1. POLICE PROTECTION: Patrolling, radio response to calls and other routine police services using present personnel and equipment will be provided on the effective date of annexation. Necessary personnel will be added as population warrants.
- **2. FIRE PROTECTION:** Fire Protection by the City's Fire Department is currently being provided under the Rural Fire Protection Contract and on the effective date of annexation, the protection will be provided as the regular fire protection of the City of Rio Hondo, Texas. Services of the Fire Marshal for fire prevention will be available upon annexation.
- 3. EMERGENCY MEDICAL SERVICES: Emergency Medical Services will be provided by the Harlingen Community Emergency Care Foundation, Inc. for ambulance services as provided under the present contract or by which service provider the City of Rio Hondo has arrangements with.
- 4. <u>CODE ENFORCEMENT:</u> Code Enforcement services, including the application and enforcement of zoning, Building Code, Electrical Code, Plumbing Code, Mechanical Code, and other Municipal Code requirements adopted by the City of Rio Hondo shall be made available immediately upon annexation.
- <u>5.</u> <u>PARKS AND RECREATION:</u> Residents of the area will be entitled to *use all* City of Rio Hondo parks, playgrounds, recreational and library facilities upon annexation.
- 6. SOLID WASTE COLLECTION: Pick up of garbage and trash through existing City of Rio Hondo services contract will be made available on the effective date of annexation.
- 7. POTABLE WATER: Water for domestic and commercial uses will be available at City rates from any existing City lines on the effective date of annexation and, thereafter, from any new lines as extended to the area by the City and/or developers as land is developed in accordance with City Ordinances and policies. Maintenance of any public water lines will be taken over by the City after being in use one year after date of annexation, in accordance with City Ordinances and Policies.
- **8. WASTEWATER:** Wastewater service is now being provided for a portion of that area to be annexed. The remainder of the area to be annexed shall be provided

with wastewater service within the required timetable at City rates.

9. STREET AND ROAD MAINTENANCE: The only street or road way is FM 106 (East Colorado Avenue) is a State Farm to Market Road, a very recently reconstructed road into a four-lane highway, with curb and gutter and sidewalks. Future

maintenance of this roadway will be done by the Texas Department of Transportation.

Traffic signs, street markings and other traffic control devices will be installed as needed as established by appropriate study and requirements of the Texas Department of Transportation.

- **10. STREET LIGHTING:** Street lighting will be installed as provided by City Policies and Regulations.
- 11. MAINTENANCE OF PUBLIC FACILITIES: The existing public facilities in the area consist of water lines and some wastewater lines will be maintained by the City of Rio Hondo. Maintenance of public facilities will be provided in accordance with City Ordinances and policies.
- **B]** Capital Improvements to be initiated within the two (2) years of the effective date of the annexation in order to provide municipal services, adequate to serve the particular area and to be substantially completed within four and one half (4V2) years of the effective date of the annexation.

RESOLUTION OF THE CITY OF RIO HONDO, TEXAS

ADOPTING THE PROPERTY TAX RATE REFLECTED IN THE CITY'S FISCAL YEAR 2025-2026 OPERATING BUDGET

WHEREAS, as per Local Government Code Sec. 102.007(c), the adoption of a budget that will require raising more revenue from property taxes than in the previous year requires a separate vote of the governing body to ratify the property tax increase reflected in the budget; and

WHEREAS, the Fiscal Year 2025-2026 Budget, as adopted, requires raising more revenue from property taxes than in the previous year and includes a same in the property tax rate of 0.0408012; \$656,820.97 to \$766,132.12 which is an increase of \$109,311.15 per \$100.00 valuation; and

WHEREAS, this ratification vote is in addition to and separate from the vote to adopt the budget or a vote to set the tax rate required by Chapter 26, Tax Code, or other law;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS:

Section 1. The City Commission of the City of Rio Hondo, Texas, hereby ratifies the property tax increase reflected in this year's City budget, as adopted by this City Commission, which will raise total property tax revenue to last year's City budget by \$109,311.15 or 0.8573% and, of that amount \$_109,311.15 is tax revenue to be raised from annexations and new property added to the tax roll this year.

Section 2. This resolution shall take effect immediately from and after its adoption and is accordingly resolved.

ORDINANCE NO 2025-03

AN ORDINANCE OF THE CITY OF RIO HONDO, TEXAS, LEVYING AD VALOREM TAXES FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF RIO HONDO, TEXAS, BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026; PROVIDING FOR APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; PROVIDING FOR A DEADLINE; PROVIDING FOR A LIEN ON REAL AND PERSONAL PROPERTY TO SECURE THE PAYMENT OF TAXES ASSESSED; AND DEALING WITH RELATED MATTERS

WHEREAS, the City Commission approved the municipal budget for the fiscal year beginning October 1, 2025 and ending September 30, 2026;

WHEREAS, the City Commission ratified the property tax revenue increase reflected in the fiscal year 2025-2026 approved budget; and

WHEREAS, it is necessary that an ordinance be passed levying an ad valorem tax on all property, both real and personal, within the corporate limits of the City of Rio Hondo, Texas in accordance with such budget and the Texas Tax Code;

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS.

Section 1. That there is hereby levied and there shall be collected for the maintenance and operation of the municipal government of the City of Rio Hondo, Texas for the 2025-2026 Fiscal Year upon all property, real, personal and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.804012 cents on each One Hundred Dollars (\$100) valuation on property.

THIS TAX RATE IS THE SAME PERCENTAGE TAX RATE AS FY 2024-2025.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL BE THE SAME AS LAST YEAR AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$812.00

Section 2. That there is hereby levied and there shall be collected for the City of Rio Hondo, Texas as follows:

SUMMARY

The following ad valorem tax rate is adopted per \$100.00 valuation.

1. Maintenance and operations of the general government
(General Fund) \$0.624182

2. Interest and Sinking fund (Debt Rate) \$0.179830

Total Tax 0.8040127 per \$100 of valuation \$0.804012

Section 3. That all monies collected under this Ordinance for the specific items herein named, be and the same hereby appropriated and set apart for the specific purposes indicated in each item and the Assessor/Collector of Taxes, and the City Administrator shall keep these accounts so as to readily and distinctly show the amount collected, the amount expended and the amount on hand at any time belonging, to such funds. All receipts for the City not specifically apportioned are hereby made payable to the General fund.

Taxes levied under this Ordinance shall be due October 1, 2025 and if not paid on or before January 31, 2026 shall immediately become delinquent.

Section 4. All taxes shall become a lien upon the properly against which assessed, and the tax assessor and collector for the City of Rio Hondo is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and Ordinances of the City of Rio Hondo shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the interest and penalty collected from such delinquent taxes shall be appropriated to the General Fund of the City of Rio Hondo. All delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law.

Section 5. That this ordinance shall take effect and be in force on October 1, 2025.
